# 1. ENTRY INTO FORCE AND DURATION OF THE AGREEMENT

1.1. Securitas' General Terms and Conditions of Sale and Supply apply. These conditions apply as a supplement to, but take precedence over, Securitas' General Terms and Conditions of Sale and Supply 02-25, which also include definitions that constitute an integral part of the Agreement."

# 2. SCOPE AND PERFORMANCE OF SERVICES

- 2.1 <u>Services, intelligence and equipment.</u> All equipment, intelligence and investigations and/or documentation supplied by Securitas shall always be the property of Securitas, unless otherwise agreed in writing between the parties.
- 2.2 Results. Securitas shall be the exclusive owner of all results of the work performed by Securitas in the performance of the Services, unless otherwise agreed in writing with the Customer.
- 2.3 <u>License.</u> The Customer is granted a non-exclusive royalty-free license during the term of this Agreement to use reports and other materials delivered to the Customer "for internal use only."

#### 3. LIMITATIONS OF LIABILITY

3.1 Product and service liability. Securitas does not guarantee a function, result or accuracy of the Services or accept overall responsibility for the security at the Customer's Site(s). Securitas makes no representation, express or implied, that its Services will prevent or mitigate any Loss or damage.

# 4. INTELLECTUAL PROPERTY RIGHTS

4.1 Work performance. Securitas shall be the exclusive owner of the Intellectual Property Rights in all the results of the work performed by Securitas in connection with the Services (other than in documents, items and materials already owned by the Customer to Securitas in connection with the Services), unless otherwise agreed in writing with the Customer.

# COPYRIGHT

- 5.1 Copyright holder. All worldwide copyright, database right and all other rights in any data or other information collected by or for the Securitas Group or the Customer in the course of provision of the Services shall vest absolutely in the Securitas Group. The Customer shall execute such documents as the Securitas group may reasonably require for the purpose of vesting such rights in the Securitas Group.
- 5.2 <u>Use of data.</u> Securitas may use any data collected for the purpose of operating the Services for use in the provision of services to other Securitas Customers.

# INDEXED CONTENT

- 6.1 <u>Data owner.</u> Securitas does not own or control Indexed Content. Indexed Content shall not be considered the Customer's data or Customer data under any circumstances, including pursuant to the terms of any such other agreement entered into between the Customer and Securitas for non-social media monitoring Services.
- 6.2 <u>Customer risk.</u> Indexed Content is provided "as is", exclusive of any warranty whatsoever. The Customer's use of Indexed Content is at the Customer's sole risk. Securitas is not liable to the Customer, or any third party based on Indexed Content. If the Customer use Indexed Content the Customer shall indemnify Securitas from any claims whatsoever arising from such use.
